New Business

- a. Veteran Affairs Supportive Housing (VASH) Voucher Payment Standard
Hollie Ohnesorge, Assisted Housing Coordinator, explained the Department of Housing and Urban Development (HUD) awarded the City of Dubuque six (6) vouchers for the Veteran Affairs Supportive Housing (VASH) program in January 2021. This program, which was designed to assist homeless veterans, provides housing assistance along with supportive services through HCAP and Veteran Affairs. (An additional six (6) vouchers have been awarded for 2022.)

HUD recently updated regulations that allow Public Housing Authorities to increase voucher payment standards for the VASH Program up to 120% of the fair market rent. This may allow clients to find units in exception rent areas. (A copy of Item 4a is attached.)

Commissioner Sam Wooden moved to approve the Veteran Affairs Supportive Housing (VASH) Voucher Payment Standard. Commissioner Amy Eudaley seconded. Roll call. Six (6) in favor. Motion passed.

Federal Register: Section 8 Housing Choice Voucher: Revised Implementation of HUD-Veterans Affairs Supportive Housing Program Effective 9/27/2012.

“To assist HUD-VASH participants in finding affordable housing, especially in competitive markets, HUD is waiving 24 CFR 982.503(a)(3) to allow a PHA to establish a HUD-VASH exception payment standard. Without this waiver, a PHA is required to establish a single payment standard amount for each unit size.”
