1. The meeting was called to order at 3:00 p.m. by Paul Lassance. This is an official meeting as a quorum was present.
2. Chief Financial Officer Jennifer Larson certified that the meeting was in compliance with the Iowa open meetings law.
3. BTC Investment Advisors was present virtually.

BTC gave a portfolio and economic update for the quarter ending September 30, 2023. The portfolio is compliant with the City's investment policy. There is \$48,869 in cash and cash equivalents, noting a rate of 5.1%. This is two times the rate received from last year. 99.5% investments are held in triple AAA rated bond, total balance of 9,402,536. Annual income for last year totals 130,426, noting no market loss.

The Fed will hold a meeting in November. At this time it is anticipated the federal will raise rates in November and the market has already accounted for this increase. Currently the 2 year yield is higher than the five year yield. Anticipates over the next months this yield curve will return to a normal and investments will be adjusted as yield curve changes.

4. Paul Lassance moved that the minutes of the July 26, 2023, be approved. The motion was seconded by Molly Valaskey and approved unanimously.

5. Brian DeMoss reported on recent certificate of deposit results. CD bids are still 5.50% or higher.
6. The Commission reviewed the June 30, 2023, quarterly investment reports.
7. The only communication from the public was regarding interest in the City issuing a proposal for banking sevices from Capra Bank.
8. The next meeting of the Commission is scheduled for Wednesday, January 24, 2024 at 3:00 p.m. A representative from DB&T will be invited to present at the meeting.
9. Paul Lassance moved that the meeting adjourn. The motion was seconded by Josh Merritt. The meeting was adjourned at 3:40 p.m.
