Appointment of liaison to Community Development Commission

New Business

HUD audit of HPRP homeless assistance program and Department response

The Commissioners received a copy of the HUD audit of HPRP homeless assistance program and the Department response for informational purposes only.

Amendment to HPRP program administrative plan with Project Concern

David explained that this amendment is in response to the HUD audit. The proposed amendment would include adding moving cost assistance and motel and hotel vouchers to the Rapid Re-Housing Program. The amendment would also further clarify the review process by the Housing and Community Development Department. Commissioner Holz motioned to approve the amendments. Commissioner Root seconded. All present in favor. Motion passed.

Presentation: Bridges Initiative. Carroll Clark and Erica Haugen, FSS Coordinators

Carroll and Erica presented information to the Commissioners about the Bridges Initiative. Including Bridges Out of Poverty, Getting Ahead in a Just Gettin' By World and Circles.

HUD concerns regarding reduction in housing vouchers

David explained that the HUD regional office has concerns regarding the reduction in housing vouchers and staff is anticipating a formal inquiry.

Section 8 Program satisfaction survey

David shared that staff is interested in sending a survey to landlords, participants and community agencies to find out their satisfaction with the Section 8 program. Surveys will first be sent to the landlords.

David stated that Janet and her staff earned a 100% score for the 8th year in a row.

Commissioners received a summary of the complaints the Housing Department has received since the last meeting.


Newsletter
