Chairperson's Report

Commissioner Allen reported on the following NAACP activities:

- ~ Planning continues for the Freedom Fund Banquet that will be held November 14 at the Diamond Jo beginning at 6:00 p.m. The Freedom Fund Committee has identified three new awards that they will be presenting this year pending approval by the NAACP at tomorrow's meeting. Along with the Ruby Sutton Humanitarian Award, the Thom Determan SCOPE Award, and the Jerome Thomas Black Manhood Award will be presented at the Banquet. They have also connected with the DIFL and one of their organizations and will be presenting the NAACP Minority Student Dome All Sport Athlete Award.
- ~ Anthony attended the LULAC meeting where they discussed renaming the Multicultural Family Center to the Ruby Sutton Multicultural Family Center. The MFC Board Director is agreeable to the name change and will be moving forward to get that accomplished. LULAC will also be holding a mock caucus where they will be working with the colleges to educate young people on the voting process.
- ~ Later this month Anthony will be traveling to California to attend a conference on inclusion and equity with representatives from Inclusive Dubuque.
- ~ The DCPRC will be looking at holding training in February for new committee members. Leadership positions will be due for appointment as well.

- ~ The BMC will be meeting this evening to set goals for the coming year.
- ~ Anthony provided a PSA on Radio Dubuque for the Police Department regarding neighborhood safety.

He commented that it was outstanding, and from that, he is putting together a resolution to offer ways to move ahead on this issue that they have been dealing with since January/February. He asked that commissioners review the Plan for Sustainable Change prior to next month's meeting. He stated that Steve Drahazal from the Public Defender's Office has been invited to attend the November 9th meeting to provide additional information on criminal justice issues.

Commissioner Vaughn announced that Josh Jasper of Resource Unite has arranged Graham Goulden, a crime-prevention leader, to speak here in Dubuque at Five Flags on October 22. She also announced that the faces & voices MLK Breakfast planning committee has confirmed Greg Gumbel as keynote speaker at the MLK Breakfast.

Goal 2: Provide input to City Council goals and priorities and support the Human rights Commission's goals and priorities. (Full commission participation) *Allen is Chair.

Commissioners will continue to provide input to Kelly.


Goal 3: Continue to improve communication within and among community groups in order to improve human rights initiatives. (Davis, *Vaughn, Allen)
