1. Approval of minutes from the January 8, 2016 meeting. Motion by Neuhaus to approve as submitted. Second by White. Motion carried 2-0.
3. Schedule promotional examinations for the positions of Police Lieutenant and Police Captain. Motion by Neuhaus to set the promotional exam for Police Captain on May 4, 2016 at 6 p.m. and Police Lieutenant on May 11, 2016 at 6 p.m. as recommended. Second by White. Motion carried 2-0.
