Commissioner Templeton Vaughn announced that Resource Unit is holding their Outstanding Volunteer Awards night on June 1. Commissioners Parks and Davis volunteered to work with her on this. A subcommittee meeting was scheduled for May 16 at 4:15 p.m. to prepare for hosting a table at this event as well as any other upcoming events.

Nino Erba reported that he has not been successful in finding any court cases in support of the gay conversion therapy ordinance. He is requesting at the next meeting that they draft the language of the ordinance. Commissioner Fisher will proceed with scheduling a meeting for this month.
