Bee Branch Creek Greenway Completed

The City of Dubuque completed the Upper Bee Branch Creek Restoration portion of its multi-phased flood mitigation project in July 2017. The restoration project was finished 3 months ahead of schedule and \$800,000 under budget.

The project, which stretches from East 24th Street to Garfield Avenue, features a 1,938-foot-long creek and floodplain, multi-use trail system, play area with slides, spillway, scenic overlooks, raised garden beds, and an outdoor amphitheater that provides a venue for teaching and neighborhood gatherings. Officially named the Bee Branch Creek Greenway, it serves as a beautiful linear park but is also an important part of our community's infrastructure to control flooding.

During rain events, the creek will rise out of the limestone channel and cover the multi-use trail and grass. This is the way the greenway is designed -- to move stormwater through the area without flooding adjacent properties. Installing six 8-foot-diameter pipes through the railroad right-of-way will allow stormwater to drain more efficiently from the upper half of the Bee Branch Creek to the lower half. The railroad culverts project is expected to be complete in 2019.

It is not safe to be near the creek during and after rain events when the water level is high. Please practice safe behavior and do not use the greenway for recreational activities during these times.



Flood warning signs with flashing lights are being installed in the greenway to indicate



when the creek is covering the lower trail. Please be aware of these signs and do not use the lower trail system or travel under the East 22nd Street or Rhomberg Avenue bridges while these signs are flashing.

Living near a park with an urban stream, or even just visiting one, is a new experience for many families. It is important to talk to your children about the risks related to fast-moving stormwater and rain-swollen streets and creeks. Due to stormwater runoff entering the creek and the varying depth of the water, **swimming and wading is prohibited in the Bee Branch Creek at all times**. There is also no playing on or splashing in the 22nd Street spillway or amphitheater water feature.

The Bee Branch Creek Greenway accommodates many types of recreational use. However, due to safety, there are some activities that are prohibited. Please follow these park rules:

Allowed

- Fishing in the Bee Branch Creek is allowed.
- Non-motorized skateboards, bicycles, scooters, and hoverboards are allowed.
- Pets on leashes are allowed in the Bee Branch Creek Greenway; clean-up is required in all areas.
- Canoeing, kayaking, and stand-up paddle-boarding are allowed in the creek from

the railway yard to Kerper Boulevard.

- Geocaching is allowed in the Bee Branch Creek Greenway.

Prohibited

- Swimming and wading is prohibited in the Bee Branch Creek at all times.
- For your safety and the safety of others, please do not throw rocks or play on rocks.
- Ice skating is prohibited on the Bee Branch Creek and 16th Street Detention Basin.
- Canoeing, kayaking, and stand-up paddle-boarding are prohibited in the creek from East 24th Street to Garfield Avenue.

2017 Water Quality Reports Available

The Dubuque Water Department has published the annual water quality reports for the Dubuque, Vernon, and Barrington Lakes water supplies. All three systems met state and federal water quality requirements and had no drinking water violations in 2016.

The City of Dubuque purchased the Barrington Lakes and Vernon water systems in 2016 and is responsible for their operation, maintenance, and management. The water supplies for these systems are currently separate from each other and from the City of Dubuque's water supply, with connection of these systems to the Dubuque water supply scheduled for later this year.

Printed copies of the Dubuque water quality report are available at several locations including City Hall (50 W. 13th Street) and the Carnegie-Stout Public Library (360 W. 11th Street). Printed copies of the Vernon and Barrington Lakes water quality reports are available by request.

When compared to the other six large cities in Iowa that soften their drinking water, Dubuque has the third-lowest rate at \$28.43. That monthly rate translates to just 47 cents for 100 gallons of drinking water. The average cost for a 16.9 ounce bottle of bottled water at a convenience store is \$1.59, which translates to over \$1,200 for 100 gallons of bottled water.

A MESSAGE from the CITY MANAGER

Two separate storms struck Dubuque in July, impacting parts of our community in different ways, but both proved Dubuque is a resilient community with support from our friends and neighbors.

The first storm occurred overnight on Tuesday, July 11, and combined recorded winds of nearly 80 miles per hour with 2-3 inches of rain in a short amount of time. The winds caused significant, widespread damage, especially to trees, throughout Dubuque. City staff from the fire, leisure services, police, engineering, and public works departments worked throughout the night to assess damage, clear roadways, repair traffic signals, and respond to other hazards including downed power lines and trees on homes.

Due to the scope of the storm damage, the City offered free collection of storm-related debris through the following week, with the public works department crews making collections through the weekend. Between July 12 and 21, public works received 1,563 phone calls related to the storm, collected 375 tons of debris, and expended 1,796 hours of staff time to storm response.

The leisure services department's forestry crew started at 1 a.m. the night of the storm, responding to blocked roadways and downed City-owned trees on structures and vehicles.

Additional crews came in overnight to ensure roads were open for traffic as quickly as possible. By July 31, that department had received over 340 requests for responses to tree damage across the community. That number did not include tree damage or loss in numerous parks and other City properties, including Bunker Hill Golf Course, which was closed for one day following the storm. Parks were prioritized to prepare for weekend rental events. The City's urban forester, Tom Kramer, said this storm caused more damage than any other in the past 40 years.

With assistance from Dubuque County Emergency Management Coordinator Tom Berger, a storm clean-up assistance program was created within a day and offered to Dubuque residents in need of assistance getting storm-related tree/yard debris off their property. The program was made possible by assistance from United Way and volunteer teams of "chainsaw responders" from United Methodist Church Iowa Conference Disaster Services and St. Mark's Lutheran Disaster Response Team from Cedar Rapids. The groups provided nearly 120 volunteer hours of assistance to 25 Dubuque residents over four days. Additional assistance was provided by volunteers from United Way, AmeriCorps, Boy Scouts, John Deere, Wahlert High School, and the American Red Cross.

Just one week later, during the community celebration for the completion of the Bee Branch Creek Greenway, another storm hit Dubuque. While this storm did not cause major damage, it did warrant a severe thunderstorm warning and delivered heavy rain and strong winds.

Then, on Friday, July 21, another storm hit overnight. The National Weather Service had an unofficial report of 4.9" of rain that fell in less than 24 hours. Statistically, this was between a 10-year and a 100-year event. Rainfall totals from the July 21-22 event varied across Dubuque with some areas experiencing a 10-year event while others a 100-year event. (A "10-year event" has a 10 percent chance of occurring in any given year while a "100-year event" has a one percent chance of occurring in any given year.)

Thankfully, because some of the phases of the Bee Branch Watershed Flood Mitigation Project were in place prior to the storm, water-related property damage was largely avoided. In 2002, a similar rainstorm that dropped 4.9" of rain in a 24-hour period resulted in enough property damage to warrant a Presidential Disaster Declaration.

As in the past when people in our community were in distress, everyone pulled together to help, including City staff. This was combined with the planning and investment conducted by the Mayor and City Council, in partnership with the neighborhoods, to create and begin implementation of the Bee Branch Watershed Master Plan. §
