Goal #3: Employment – GDDC (Kristin Dietzel), NICC (Erin Powers-Daley)

Kristin and Erin were invited to share information on workforce and educational programs and partnerships as it relates to their training and skill building opportunities.

Kristin provided an overview of GDDC workforce programs: Dubuque Works; Opportunity Dubuque; HR Action & Workforce Assistance; Data Analytics & Prospect Development; Newcomer Services; and Distinctively Dubuque. They partner with employers to identify workforce opportunities, develop proactive solutions, and works to retain the workforce.

Erin at NICC work closely with Opportunity Dubuque in meeting employers needs for a qualified workforce. Through the Success Model Program, they offer education and outreach opportunities and the use of success coaches, to assist students with navigating the services and resources available. The coaches help students maneuver any barriers through education and training and then works with them to obtain employment or additional training at NICC.

Jackson provided a brief update on the planning for the Race Conference. A press conference announcing the Race Conference was held Friday, June 21, 2019.

Commissioner Allen stated that the Commission is tasked with planning the format for the community forum that will be part of the Race Conference. Schiesl and Breitfelder volunteered to work with Allen on the planning committee. They will meet at 5:30 pm on July 11 at the MFC. He asked that Commissioners promote the conference to any groups or organizations they have partnerships with.
