Odd/Even Snow Route Policy Changed

Dubuque's odd/even snow route parking policy, which allows City crews to plow the streets more effectively, improve driving conditions, and provide better on-street parking, was amended in July.

THE CHANGES: Parking restrictions will be enforced during the entire posted and declared time period, with no allowance for parking prior to the end of the posted time period or after a perceived plow pass. The first ticket of each winter season will be forgiven if the recipient submits his or her telephone number for subsequent

declaration notifications through the City's CodeRED system. Second and subsequent violations will result in a \$30 fine.

POLICY BACKGROUND: When the snow route policy is declared, the program requires "odd/even" parking along the designated snow routes. When in effect, parking is prohibited on the "even numbered" side of the streets on the even days of the month and on the "odd numbered" side of the streets on the odd days of the month. The parking restrictions are in effect from noon to 5:00 p.m. OR 1:00 a.m. to 6:00 a.m., depending upon the street.

Enforcement of the snow route parking policy is announced at least six hours in advance through area news media, including CityChannel 8 and the City of Dubuque website, as well as the City's CodeRED emergency notification system.

City Adds Emergency Notification System

The City of Dubuque has instituted the "CodeRED" Emergency Notification System, a high-speed telephone communication service for emergency notifications and other important messages. This system allows local officials to telephone all or targeted areas of the city or county in case of an emergency situation that requires immediate action.

The CodeRED system offers geographic targeting of calls coupled with a high-speed telephone calling system capable of delivering customized pre-recorded emergency messages directly to homes and businesses at the rate of up to 60,000 calls per hour. If the call is not answered, CodeRED's technology will deliver the message in its entirety to voicemail and answering devices.

The Dubuque County 911 System's phone number and address database is being used as the phone number database for the CodeRED system. Dubuque residents with unlisted phone numbers, anyone who has changed his or her phone number or address within the last year, and anyone who uses a cellular phone as their primary phone number should register their number with the service to insure their number is in the database. Additionally, residents can add an alternate number, such as a cellular phone, to their record if they wish. Providing an alternate phone number will cause both the primary and alternate phone numbers to be contacted in the event a call goes out for the address specified.

CodeRED allows individuals and businesses to add their phone numbers directly to the database through the Internet. To add a phone number to the database, Dubuque residents should visit www.cityofdubuque.org and click on the "CodeRED Alert System" link. This will take visitors to a CodeRED website where they can submit their information.



CodeRED is a geographical-based system, so street addresses are needed to select which phone numbers will receive an emergency notification call in any given situation. Cell phone numbers are fine, but an address must be associated with the number.

The City of Dubuque plans to use the service to notify residents who live on Dubuque's snow routes when the odd/even parking policy is implemented this winter.

The information provided for the database will be used only for government notification purposes. The message can be delivered in text format to hearing impaired individual's TTY/TDD equipment. The phone numbers of individuals who request to have their numbers removed from the system will be removed. The CodeRED system will not be used for severe weather warnings or information. Residents should rely on local media that use the Emergency Alert System (EAS) or NOAA all-hazards radios. ■

Winter Set-Out Tips for Solid Waste

- Do not use white plastic bags in the winter. They can be mistaken for snow and missed by crews.
- Use a lid and keep the inside of your can clean and dry so the contents won't be frozen to the can. If rain or snow gets inside, there is a greater chance of the contents freezing to the container.
- Place smaller bags inside the can at the top.
- Please make sure your containers are accessible for crew collection.

The Digital Television Transition

On February 17, 2009, full-powered broadcast television stations will stop broadcasting in analog and only send out digital signals. If you subscribe to a pay video service like cable or satellite, you won't need to do a thing. Those services will continue to provide you with an analog signal.

If you watch over-the-air television by receiving signals through an antenna, you might not be able to watch anymore. It all depends on whether your television set can receive digital signals. Check your TV's instruction booklet or ask at the store where you bought your set. Chances are, if you bought the set within the past year or two, it has a digital tuner. If you have an old set, you probably don't.

If you don't have a digital tuner in your television and you watch over-the-air signals received through an antenna, you'll need to do one of the following three things to keep watching TV after February 17, 2009:

1) Subscribe to a pay service like cable or satellite;

2) Get a converter box that will receive the new digital signals and convert them to analog. Most stores that sell televisions will sell the converter boxes. Generally, they cost between \$50-\$70 dollars. The federal government will provide each household with two \$40 coupons towards the purchase of two approved converter boxes. You may only use one coupon per converter box and the coupons expire 90 days after they are mailed to you. You can apply for the coupons online at www.dtv2009.gov or call 1-888-DTV-2009; or

3) Purchase a new television set. Stores are required to disclose if the TV you're buying does not have a digital tuner in it. Please note that buying a TV with a digital tuner does not mean you have to buy an expensive high definition (HD) set. While all HDTV is digital, not all digital TV is HD.

Human Rights Speakers Bureau Expands Topics

The Dubuque Human Rights Commission Speakers Bureau has expanded to include speakers on race, national origin, and disability.

The speakers bureau is a free service which was initially launched in January of 2007 and focused on sexual orientation issues. It offers short presentations given by community volunteers. They are available to speak to a wide variety of groups including schools, classes, businesses, civic groups, religious

organizations, or parents. Groups interested in having a speaker can request the topic of their choice.

Kelly Larson, director for the Dubuque Human Rights Department said, "The speakers bureau is an educational resource to help people connect with others from various backgrounds."

Presentations will also include brief information on human rights law and biographies of the speakers. Each

presentation will include significant time for input, questions, and discussion regarding the specific issue being presented. Molly Menster, Human Relations Specialist for the Dubuque Human Rights Department, added, "This initiative is also meant to place a human face on an abstract issue. We invite the Dubuque community to use this program and the speakers as resources." To request a speakers bureau presentation, call the Human Rights Department at 589-4190. ■
