Odd/even snow route parking policy changed

Parking now prohibited throughout entire declaration period

DUBUQUE, Iowa – As winter approaches and City of Dubuque staff prepare for snow and ice control operations, the City is reminding residents that Dubuque’s odd/even snow route parking policy was amended in July and the change will be enforced this season.

The policy’s parking restriction was amended and will now be enforced during the **entire posted and declared time period, with no allowance for parking prior to the end of the posted time period or after a perceived plow pass.** The first ticket will be forgiven if the recipient submits his or her telephone number for subsequent declaration notifications through the City’s CodeRED system. Second and subsequent violations will result in a \$30 fine.

Dubuque’s odd/even snow route parking policy is designed to allow City crews to plow the streets more effectively, improve driving conditions, and provide better on-street parking. When the policy is declared, often after snowfalls of three inches or more, the program requires “odd/even” parking along the designated snow routes. When in effect, parking is prohibited on the “even numbered” side of the streets on the even days of the month and on the “odd numbered” side of the streets on the odd days of the month. The parking restrictions are in effect from noon to 5:00 p.m. OR 1:00 a.m. to 6:00 a.m., depending upon the street.

Implementation of the snow route parking policy is announced at least six hours in advance through area news media, including CityChannel 8 and the City of Dubuque website. Additionally, the City will use the new CodeRED emergency notification system to phone residents who live on the odd/even snow route. CodeRED is a high-speed telephone communication service for emergency notifications and other important messages that allows geographic targeting of automated telephone calls.

The Dubuque County 911 system’s phone number and address database is being used as the phone number database for the CodeRED system. Residents with unlisted phone numbers, anyone who has changed his or her phone number or address within the last year, and anyone who uses a cellular phone as their primary phone number should register their number with the service to insure their number is in the database. Additionally, residents can add an alternate number, such as a cellular phone, to their record if they wish. Providing an alternate phone number will cause both the primary and alternate phone numbers to be contacted in the event a call goes out for the address specified.
