Library Awarded Prestigious LEED® Green Building Certification

The Carnegie-Stout Public Library has been awarded LEED® Silver certification in the Existing Building category, established by the U.S. Green Building Council and verified by the Green Building Certification Institute (GBCI). LEED is the preeminent program for the design, construction, and operation of high-performance green buildings. The library is the first City-owned building to achieve this distinction, and the only public library in the nation to achieve this status while also being on the National Register of Historic Places.



Carnegie-Stout Public Library achieved LEED certification for energy use, lighting, water, and material use, as well as incorporating a variety of other sustainable strategies. By using less energy and water, LEED-certified buildings save money, reduce greenhouse gas emissions, and contribute to a healthier environment for residents, workers, and the community at large.

Merry Mulch and Winter Yard Debris Collection Schedule

The City will provide a "Merry Mulch" collection of natural Christmas trees, food scraps, and yard debris on regular collection days for two weeks from Monday, Jan. 7, through Friday, Jan. 18. Trees must be free of decorations and have an attached City brush tie or yellow yard waste sticker.

Before and after "Merry Mulch" and through March 28, appointments must be made to have yard debris and food scraps collected. Collections will be on Thursdays only and appointments must be made no later than 3 p.m. on Wednesdays for next-day collection. Customers can schedule a collection by calling the Public Works Department at 563-589-4250 or by submitting a service request online at www.cityofdubuque.org/yardwaste. Current, annual yard waste decals or yellow single-use yard waste stickers are required.

Dornbirn Named Dubuque Sister City

A Dubuque delegation, including Mayor Roy Buol and City Clerk Kevin Firnstahl, traveled to Europe in late October to formally establish a sister city relationship with Dornbirn, Austria. A sister city relationship is an officially approved, long-term partnership between two municipalities in two countries, with the purpose of establishing mutually beneficial connections and addressing issues relevant to both locations.

Located in the Upper Rhine Valley, Dornbirn is the largest city in the Austrian state of Vorarlberg and has a population of nearly 46,000. The city is located among diverse cultural and natural settings in the four-country area of Austria, Germany, the Principality of Liechtenstein, and Switzerland.

The visiting Dubuque delegation also included Dick Landis, chairperson of Dubuque's Sister City Relationships Advisory Commission, and several members of the Rhomberg family of Dubuque. Early Dubuque settlers L.A., Joseph, and Francis Rhomberg were born in Dornbirn before coming to Dubuque

and finding success in the distilling/ brewing, wholesale liquors, railroad, and tanning/fur industries.

In the 1990s, Austrian author Meinrad Pichler traveled to Dubuque to research the history the two cities share. In 2009, the City of Dubuque was contacted by Dornbirn's Public Relations Director Ralf Hammerle about a visit to Dubuque to further explore the connection and establish a sister city relationship. Since then, Dubuque has hosted delegations from Dornbirn in 2010 and 2011. The City of Dubuque was then invited to visit the City of Dornbirn, and a reciprocal visit was planned for October 2012.

The recent visit to Dornbirn included tours of the Dornbirn City Museum and Archives, the Dornbirn Town Hall, farmer's market, area historical sights, and medieval villages. Proclamations (one in English and one in German) officially designating Dubuque and Dornbirn as sister cities were signed by Mayor Buol and Dornbirn Mayor Wolfgang Rummele at a formal ceremony on Oct. 24 at the Dornbirn Town Hall.

Additional copies of Pichler's book were provided by the City of Dornbirn and are available for reading at the Carnegie-Stout Public Library, the Dubuque County Historical Society, and the Center for Dubuque History at Loras College.

Reminder for Rental Property Owners

Year (FY) 2014 (July 1, 2013 - June 30, 2014) to the City Council at their regular meeting on Monday, Feb. 4, 2013. Over the course of seven public meetings in February, City staff from each department and division will present budget information to the City Council. The final public meeting will be to adopt the budget.

ACCOLADES FOR COMPLETE STREETS

Since its completion in May 2012, Dubuque's Historic Millwork District Complete Streets Project has been recognized, not only for its sustainable design of safe travel and access to all users, but also for its role in the revitalization of the district.

In September, the project was named "Project of the Year in Transportation" in the "Greater than \$5 Million, Less than \$25 Million" category from the Iowa Chapter of the American Public Works Association. Around the same time, it was named a "Top 10 Road" of 2012 by Roads & Bridges magazine.

Locally, Dubuque Main Street named the Complete Streets Project the "Best Public Improvement Project" at its annual awards banquet held in October. Preservation Iowa recognized the historic preservation aspect of the project with an award in the "Sustainability in Preservation" category at the 2012 Preservation at Its Best Awards ceremony.

The project garnered recognition at two conferences in Ames in early November; one for excellence in planning and the other for excellence in concrete. The

Complete Streets received an Iowa Award for Implementation by the American Planning Association (APA) at the annual APA-Iowa conference. The other award, a 2012 Excellence in Concrete award for sustainable practices, was received at the Iowa Better Concrete Conference.

Most recently, the 1000 Friends of Iowa group named the project "Best Development—New Civic Project" for its adherence to Smart Growth Principles. The Best Development Awards recognize development projects and programs across the state of Iowa that best reflect the principles of smart growth and sustainable development.

However, the highest award the project has received has been the local banks and developers investing tens of millions of dollars of their hard-earned capital in redeveloping the buildings in the Historic Millwork District. Special thanks to Gronen Restoration and American Trust and Savings Bank upon completion of the CARADCO Building.

Water Meter Wire and Transmitter Relocation Assistance

If a water meter, wire, or meter interface unit (outside transmitter) needs to be relocated or detached from your home or business, (for painting or residing, for example) please contact the Water Department at 589-4304 and a staff person will disconnect and reconnect it free of charge. Tampering with any part of the meter reading system may result in a \$50 fine plus repair costs and a service fee. §
