## Come to the Table: Input Sought on City Budget

Dubuque residents and stakeholders are invited to “come to the table” as City staff prepares the City’s budget for fiscal year (FY) 2017, which runs July 1, 2016 – June 30, 2017. The public is encouraged to “come to the table” and bring “ingredients” (their input related to the city budget) to create a “meal” (budget) that will serve the entire community.

Staff are inviting the community to come to the table on Wednesday, Nov. 18, in the Multicultural Family Center at 1157 Central Ave. from 6 – 7 p.m. City staff will provide some general information on the budget process at this meeting and then

residents and stakeholders are invited to share their thoughts on what they would like to see funded in their neighborhoods and the community at-large.

People unable to attend the meeting are invited to provide feedback by completing a brief questionnaire by Nov. 22 at City budget kiosks on display at: City Hall at 50 W. 13th St., the first-floor lobby of the Historic Federal Building at 350 W. Sixth St., Carnegie-Stout Public Library at 360 W. 11th St., Multicultural Family Center at 1157 Central Ave., and the

Leisure Services Department at 2200 Bunker Hill Rd. Additionally, public input can be submitted through an online form at [www.cityofdubuque.org/budget](http://www.cityofdubuque.org/budget).

Input collected through this fall’s community engagement efforts will be reviewed by staff and will assist in the development of a recommended FY2017 budget to be submitted to the City Council in

January 2016. A report will be made available to all who provided input showing how the input received was used. The City Council will then consider the recommended budget and the public will have additional opportunities to offer input during seven

public meetings in February and early March. A final budget must be adopted by March 15.

The City’s operating budget (day to day costs of providing city services) is around \$120 million and the capital budget, which includes major projects and improvements, is approximately \$80 million. 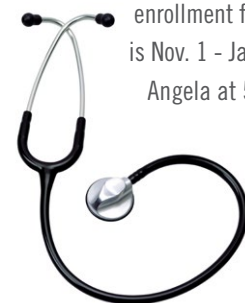

## MAKING SENSE OF ‘DOLLARS AND CENTS’

The City of Dubuque is committed to transparency and accountability in all its operations, especially when it comes to how city funds are spent. The City recently launched a new online tool that provides unprecedented access to City expenditure information. Technically speaking, this tool is considered an open data financial transparency app. By visiting [dollarsandcents.cityofdubuque.org](http://dollarsandcents.cityofdubuque.org), anyone can see detailed information on the City’s operating expenses, operating revenues, and capital improvement project expenses. The goal is to provide data in a citizen-friendly way including charts, graphs, and images are easy to understand.



## Arts and Culture Master Plan Feedback Requested

## Emerald Ash Borer Confirmed in Dubuque

Emerald Ash Borer (EAB) infestations have now been confirmed in 28 Iowa counties, including Dubuque County and the city of Dubuque. The EAB is a small, metallic green, non-native invasive pest whose larvae feast on the inner bark of ash trees, ultimately disrupting their ability to transport nutrients and causing the tree's eventual decline and death.

In preparation for the Emerald Ash Borer arrival, the City has inventoried trees on right-of-ways and other public property and found that ash trees make up 24 percent of the City's total street tree canopy. The City is in the early stages of implementing the management plan created in preparation for the infestation.

Residents concerned about their privately owned ash trees can check for the following symptoms since these symptoms are usually apparent before the insects are spotted:

- Canopy/crown thinning and dieback starting at the top
- 1/8 inch D-shaped exit holes on trunk or branches
- Suckers sprouting on lower limbs and trunk
- Woodpecker flecking activity on tree branches

## Prevent Water Meters from Freezing

The City of Dubuque Water Department reminds you to make sure that the plumbing and water meter in your home or business are properly protected from freezing. Verify that your basement/utility room windows are tightly sealed from summer use and that there is proper heating provided to these areas. If you use heat tapes, make sure they are properly installed and are working safely. If your water meter freezes, you are responsible for the cost of repairs or replacement for a damaged water meter. Please take the time now, before winter arrives, to ensure that the plumbing and water meter in your home or business are properly protected. §



The City of Dubuque offers rebates for property owners who install front or rear yard lighting that also projects onto a public sidewalk or other public areas. Front yard lighting is eligible for a 50% rebate up to \$250 and rear yard lighting is eligible for a 50% rebate up to \$100. To be eligible to receive the rebate, first contact the Building Services Department to arrange for a preliminary inspection of your site.
