## COVID-19 Vaccines: Our Best Shot to End the Pandemic

Getting vaccinated for COVID-19 when you are eligible is one of the best ways to protect yourself and others from COVID-19, to get our community and country back to normal, and to restore and protect our economy.

Wearing masks, social distancing, frequent hand washing, and staying home when ill help reduce your chance of being exposed to the virus or spreading it to others, but these measures are not enough. Vaccines will work with your immune system so it will be ready to fight the virus if you are exposed. This combination of getting vaccinated and following recommendations to protect yourself and others will offer the best protection from COVID-19.

### How and when can I get vaccinated?

Vaccinations are being given first to priority groups decided by the CDC and Iowa Department of Public Health. Iowans age 65 and over, as well as some designated high-risk populations, are eligible to be vaccinated now and will be contacted by their healthcare provider when they can schedule an appointment to be vaccinated. Vaccine supplies are extremely limited and will determine how quickly this phase of vaccinations will be completed.

As vaccine supplies increase over the coming weeks and months, additional groups will be prioritized for vaccination in phases. Vaccinations will be free and are expected to be available to all adults at healthcare providers, pharmacies, and vaccination clinics when supplies increase. ### Are the vaccines safe?

COVID-19 vaccines meet the same safety standards as all other vaccines and have been tested extensively in the laboratory and with humans to ensure their safety. Tens of thousands of Americans participated in clinical trials to test how the vaccines protect and affect people of different ages, races, and ethnicities, as well as people with different medical conditions.

As of February 1, more than 30 million doses of the vaccines have been administered to Americans. Most people do not have serious problems after being vaccinated but some have reported a headache, body aches, or fever. These side effects usually go away on their own within a few days and are a sign their immune systems are doing what they are supposed to do: working and building up protection. The possibility of having an allergic reaction is rare and extremely small.

### How do the vaccines work?

The vaccines already in use and under development help protect you from the virus by creating an antibody response -- "teaching" our immune systems to recognize and fight the virus. These mRNA vaccines do not use the live virus that causes COVID-19 so you cannot get COVID from the vaccine.

### I've recovered from COVID-19. Do I still need to be vaccinated?

Yes, even if you have had COVID and recovered, you should still get vaccinated. About 10% of people who were infected with COVID develop a weak antibody response that wears off in approximately 90 days and they could be reinfected. We can't predict who will fall into this spectrum of weak antibody responses, but the milder your previous COVID infection, the more likely you developed a weaker antibody response. Vaccines would protect you and give you the optimal antibody response. §

# Dubuque Initiatives Offers Loan Program to Help Dubuque Businesses Impacted by COVID-19

Dubuque Initiatives has partnered with the East Central Intergovernmental Association (ECIA) and the COVID-19 Business Helpline to relaunch the Dubuque Initiatives Loan Program.



The program authorizes the use of \$500,000 of Dubuque Initiatives' funds to provide loans to small businesses existing in the city of Dubuque. Completed applications will be processed within 48 hours, providing our local employers critical funding to weather the storm.

Loans of \$10,000 would be repaid over a three-year period at 1% interest. No

interest or fees would be charged to the applicant for the first 6 months after disbursement.

### Applicant Requirements:

- Employ 1-50 employees (Sole proprietors are eligible)
- Have a physical location or storefront within the city of Dubuque
- Businesses that previously received a loan through this program and non-profits are eligible to apply.

# Residents May Be Eligible for Refund with Earned Income Tax Credit

Hawkeye Area Community Action Program (HACAP) can assist residents in determining if they are eligible for up to a \$6,600 refund with the Earned Income Tax Credit (EITC). The EITC is for anyone who worked at any time in 2020 and refunds vary depending on number of eligible children and income.

# A MESSAGE from the CITY MANAGER

The Dubuque Police Department recently completed its compilation report of crimes for calendar year 2020.

“Confirmed Shots Fired” is one of the many metrics tracked by the police department annually. In 2020, there were 17 instances of confirmed shots fired in Dubuque, an increase of one over 2019’s total of 16 and down significantly from 2015’s total of 33. Of last year’s 17 cases, an arrest of at least one individual was made in 9 of those cases thanks in large part to exceptional police work with the assistance of Dubuque’s network of traffic/security cameras. The unresolved cases remain open with viable suspects identified in several.

While a single murder or instance of confirmed shots fired is too many,

Dubuque’s totals are lower than many other communities (see Table 1 below.)

When comparing Dubuque’s “Part I” crime totals for 2020 to 2015, Dubuque has had a 32% reduction in overall crime. A comparison of 2020 versus 2019 shows the total number of crimes rose by just three crimes, from 1,509 to 1,512.

The police department’s annual crime report is shared with the FBI and includes “Part I Crimes” in two categories: Crimes Against Persons and Crimes Against Property (see Table 2 below.)

The number of **Crimes Against Persons** in Dubuque in 2020 rose 40.5% from 2019 to a total of 267, including one murder, 105 sexual

assaults, 26 robberies, and 135 aggravated assaults.

While it is impossible to prevent some crimes from occurring, it is important to know that the Dubuque Police Department excels in solving crimes. In 2020, the Dubuque Police resolved 92.3% of all Crimes Against Persons committed in the city. The national average for 2019 (the most current on record via FBI data) was 45.4%.

The number of **Crimes Against Property** declined 5.6% from 2019 to a total of 1,245, including 219 burglaries, 148 burglaries to motor vehicle, 808 thefts, and 70 thefts of motor vehicles.

The goal of the City’s approach to public safety is to make Dubuque the safest community possible with the understanding that community safety is not just about injury prevention and crime prevention; it is about increasing well-being and building a vibrant, engaged, and equitable community.

Working to ensure residents experience an increased sense of well-being, a sustainable quality of life, a reduction in the numbers and cost of injuries, the preservation of income and assets, and improved perceptions of safety is a top priority for Dubuque city government. §
