

To the best of our knowledge, R&W Restoration, LLC has the experience, workforce and equipment to properly complete this contract. We recommend award of this project to R&W Restoration, LLC in the amount of \$170,750.00.

The Engineer's estimate for this project was \$183,000.00 which did not include Add Alternate No. 1 since this was included in Addendum 1. The low total bid of \$170,750.00 is \$12,250.00 below the original Engineer's estimate.
