



**Time and Place for Filing Sealed Proposals.** Sealed bids for the work comprising as stated below must be filed before 2:00 p.m. on the 19th day of February, 2015, in the Office of the City Clerk, City Hall - First Floor, 50 West 13th Street, Dubuque, Iowa.

**Time and Place Sealed Proposals Will be Opened and Considered.** Sealed proposals will be opened and bids tabulated at 2:00 p.m. on the 19th day of February, 2015, at City Hall - Conference Room A, 50 West 13th Street, Dubuque, Iowa, for consideration by the City Council (Council) at its meeting on 2nd day of March, 2015. The City of Dubuque, Iowa, reserves the right to reject any and all bids.

**Time for Commencement and Completion of Work.** Work on each improvement shall be commenced within 10 days after the Notice to Proceed has been issued and shall be fully completed by the 1st day of September 2015.

**Bid Security.** Each bidder shall accompany its bid with a bid security as security that the successful bidder will enter into a contract for the work bid upon and will furnish after the award of contract a corporate surety bond, acceptable to the governmental entity, for the faithful performance of the contract, in an amount equal to one hundred percent of the amount of the contract. The bid security shall be in the

amount of ten percent (10%) of the amount of the contract and shall be in the form of a cashier's check or certified check drawn on a state-chartered or federally chartered bank, or a certified share draft drawn on a state-chartered or federally chartered credit union, or the governmental entity may provide for a bidder's bond with corporate surety satisfactory to the governmental entity. The bid bond shall contain no conditions excepted as provided in this section.

**Contract Documents.** Copies of the construction documents may be obtained at the Engineering Department, City Hall - Second Floor, 50 West 13th Street, Dubuque, Iowa, 52001. Plans are also available online at [www.cityofdubuque.org/bids](http://www.cityofdubuque.org/bids). No plan deposit is required.

**Preference for Iowa Products and Labor.** By virtue of statutory authority, preference will be given to products and provisions grown and coal produced within the State of Iowa, and to Iowa domestic labor, to the extent lawfully required under Iowa statutes.

**Sales Tax.** The bidder should not include sales tax in its bid. A sales tax exemption certificate will be available for all material purchased for incorporation in the project.
