

NOTICE IS HEREBY GIVEN: The City Council of the City of Dubuque, Iowa will hold a public hearing on the proposed plans, specifications, form of contract, and estimated cost for the 22nd Street Storm Sewer Improvements Project, in accordance with the provisions of Chapter 26, Code of Iowa, at 6:00 p.m. on the 2nd day of April, 2018, in the Historic Federal Building Council Chambers (second floor), 350 West 6th Street, Dubuque, Iowa. Said proposed plans, specifications, form of contract, and estimated cost are now on file in the City Clerk's Office, 50 W. 13th Street, Dubuque, IA, and can be viewed during regular business hours.

The scope of the Project is as follows: 22nd Street Storm Sewer Improvements Project (Elm to White Streets) CIP# 2642769, PROJECT# 1X0006.

The project consists of the construction of approximately 714 linear feet of 10-foot by 6-foot concrete box culvert (either cast-in place or precast) with cast in place connections on both the west and east ends of the project. The project also includes local storm sewer and intakes, roadway reconstruction (with the option of either asphalt surfacing or PCC surfacing), PCC driveway, sidewalk, and curb ramp reconstruction, PCC wall, railing, and step construction, water main replacement, sanitary sewer replacement, temporary storm water management, dewatering, mobilization, electrical conduits, fiber vaults, street lights, traffic signal replacement, miscellaneous restoration, erosion control, and traffic control.

Written comments regarding the above public hearings may be submitted to the City Clerk's Office on or before said time of public hearing. At said time and place of public hearings, all interested citizens and parties will be given an opportunity to be heard for or against said proposal.
