CAMPGROUND POLICIES

REGISTRATION: Please visit www.cityofdubuque.org/millerriverview if you do not have a reservation to reserve a campsite. You must be eighteen years of age or older.

RESERVATIONS: Reservations are **required** and may be made online or over the phone. Full payment is required at the time of reservation. All major credit cards are accepted.

REFUNDS: Full refund will be given if reservation is canceled 48 hours or more before reserved date. Cancelations under 48 hours will receive no refund. Please call 563-599-2852 to cancel your reservation(s). In the event of a weather related (i.e., flooding) campground closure, all campers will receive a full refund.

CHECK IN / OUT: Campers may check in beginning at 3:00 p.m. Campers must check out by 12:00 p.m.

VEHICLES: Quiet time is at 10:00 p.m., each camp site should have only ONE vehicle per site. No vehicles may be parked on the grass.

LENGTH OF STAY: Camper(s) are limited to a stay no longer than fourteen (14) consecutive days. At the end of a fourteen-day stay, the camper(s) must leave for at least a five-day period. If the camper(s) return at the end of the five-day period, they will be assigned a different campsite.

QUIET HOURS: The period from 10:00 p.m. to 7:00 a.m. is quiet time in the campground. All campers should be set up in their campsites and noise level must not disturb their neighbors.

PETS: All pets must be confined in a camper or attended on a leash in the campground. *Electronic leashes are not allowed.* All owners must pick up after their pet.

FIRE:

- a. Burning limited to charcoal or dried, split or sawed wood, no greater than two feet in length. No construction materials such as 2 x 4's, plywood, building materials, yard waste, papers or trash may be burned.
- b. All fires must be contained in the provided fire rings.
- c. Fires are to be kept to a size with a flame height under three feet.
- d. Fire should burn to allow for smoke and gases to rise up and away. If smoke and gases become a nuisance, the fire must be extinguished.

PARK ORDINANCES: A listing of park ordinances (rules) is provided at the information board. Campers are required to follow all park ordinances. Park ordinances may be found [here](#).



TRASH / RECYCLING: Containers are provided conveniently throughout the park. Dubuque encourages you to recycle using the provided bins.

LOSS OF CAMPING PRIVILEGE: Violation of park ordinances and/or campground policies can lead to termination of camping privileges.

HOLIDAYS: There is a two-night minimum charge per campsite on Memorial Day, July 4th, and Labor Day holiday weekends.

PAVILION RENTAL

There are three open air pavilions available for rental (Iowa, Illinois, and Wisconsin). Each building seats 24 people and costs \$24.00 to rent. Building will be rented to only one person/group per day. Electricity is available. *Pavilions will NOT be rented out on the day/evening of the fireworks display (usually July 3rd).* Call the Parks & Recreation Customer Service desk Monday through Thursday, 9:00 a.m. to 8:00 p.m., Friday, 9:00 a.m. to 5:00 p.m., and Saturday 10:00 a.m. to 1:00 p.m., 563-589-4263, to reserve a pavilion.
