### **Taxicab Driver Permit Application Requirements:**

Per City Code §4-7B-8(B)(c), an applicant will be ineligible for a taxicab drivers permit if any of the following apply:

- (1) The applicant is restricted to operating motor vehicles equipped with an ignition interlock device.
- (2) The applicant's driving privileges have been suspended, revoked, barred, canceled, denied, or disqualified in the prior three (3) year period.
- (3) The applicant has been convicted of more than three (3) moving violations in the prior three (3) year period.
- (4) The applicant has been convicted of violating the following in the prior three (3) year period:
  - Section 321.218 - operating without valid driver's license or when disqualified
  - Section 321.277 - reckless driving
  - Section 321J.21 - driving while license suspended, denied, revoked, or barred
  - Section 321A.32 - other violations (subsection 1)
- (5) The applicant has been convicted in the prior seven (7) year period of a felony, of violating section 321J.2 (OWI) or 321J.2A (persons under the age of twenty-one), or of any crime involving injury to another person, damage to the property of another person, or operating a vehicle in a manner that endangers another person.
- (6) The applicant is registered on the national sex offender registry.

**\*The Dubuque Police Department will conduct a driving and criminal background check on the applicant.**

Any of the above offenses found during the check will result in the denial of the application. Additionally, applications will be denied if either of the following apply:

- Misrepresentation on the application for a taxicab driver's permit; or
- Violations against or loss, denial, suspension, or revocation of a taxicab driver's state of Iowa class C noncommercial license or equivalent license issued by another state.

### **General Waiver**
