INTRODUCING YOURSELF TO THE CITY COUNCIL:

Once there is a vacancy for the board or commission you are applying for, your application will be reviewed by the City Council at a regular City Council meeting and appointed at a subsequent meeting.

1. You are encouraged to attend the Application Review meeting to briefly introduce yourself to the City Council and be available for any questions regarding your application. The City Clerk's Office will inform you of the meeting date via email.
2. If you are not able to attend the meeting to introduce yourself, please consider sending the City Council an email to introduce yourself and state your reasons for applying. You can contact the City Council directly at www.cityofdubuque.org/councilcontacts. Fill in the required sections and select "City Council" as the department. Your message will be received by each of the council members.
3. If attending in person, during the Boards and Commissions section on the agenda, the Mayor will ask if there is anyone present to speak to the application.
4. Step to the podium, state your name and address and then tell the City Council a little bit about yourself and why you would like to serve on the board or commission.
5. Please keep your comments to less than 5 minutes. City Council meetings begin at 6:30 p.m. in the second-floor Council Chambers of the Historic Federal Building, 350 W. 6th Street.

At a subsequent City Council meeting, the City Council will appoint applicants to the vacant term(s). The City Clerk's Office will notify you if you are appointed via email.
